

ORDINANCE NO. 01 OF 2000

**AN ORDINANCE PROHIBITING THE DISCHARGE OF  
FIREARMS WITHIN THE CITY LIMITS OF AUSTIN, ARKANSAS,  
AND ITS PROPERTIES,**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, ARKANSAS:

SECTION ONE: It shall be unlawful for any person to discharge, shoot or cause to explode any items of firearms, including, but not limited to "BB" guns and pellet guns, within the business district, or any residential area, of the City of Austin, Arkansas, or on any property owned by the City of Austin, Arkansas.

SECTION TWO: For purposes of this Ordinance, the business district of the City of Austin, Arkansas is described as:

All that area within 500 feet of any commercial property, or  
Within 500 feet of any city water or sewer pumping or processing facility,  
as well as all properties owned by the city.

SECTION THREE: Any person violating the provisions of this ordinance shall be deemed guilty of a violation, and upon conviction shall be fined accordingly, not less than \$25.00 nor more than \$100.00.

SECTION FOUR: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION FIVE: Emergency. It being necessary to preserve the public peace and safety of the inhabitants of the City of Austin, Arkansas, and other persons who use the business district, and it being found that the discharging or shooting of firearms within the residential areas and business district of Austin, Arkansas, constitutes a hazard to both life and property, an emergency is hereby declared to exist, and this ordinance being necessary for the preservation of the public peace, health and safety shall be in full force and effect immediately upon its passage and approval.
