Section WHEREAS: A petition was filed August 21, 1995, asking The City Council of Austin, Arkansas in Lonoke County to abandon Streets and alleysways not dedicated and utilized within the City Limits of Austin, Arkansas that now appear on record in Plat Book 52 Page 4 in the Office of the Recorder of Lonoke County.

Section II WHEREAS: Notice for a Public hearing was posted for September 7, 1995. The hearing was held at 7:00p.m. All persons attending were heard and no one opposed.

Section III WHEREAS: The City Council states that the unused Streets and alleyways serve no purpose, and there are roads beds installed and that said streets and alleysways, herein mention and seen on map have never been utilized by the City of Austin, Arkansas, Lonoke County.

Section IV WHEREAS : A MAP OF STREETS AND ALLEYSWAYS being used and utilized by the City of Austin, Arkansas is attached to this Ordinance.

Section V WHEREAS: An emergency is therefore declared and this ordinance being necessary for the preservation of the public peace, health and safety shall be in full force and effect from and after its passage.

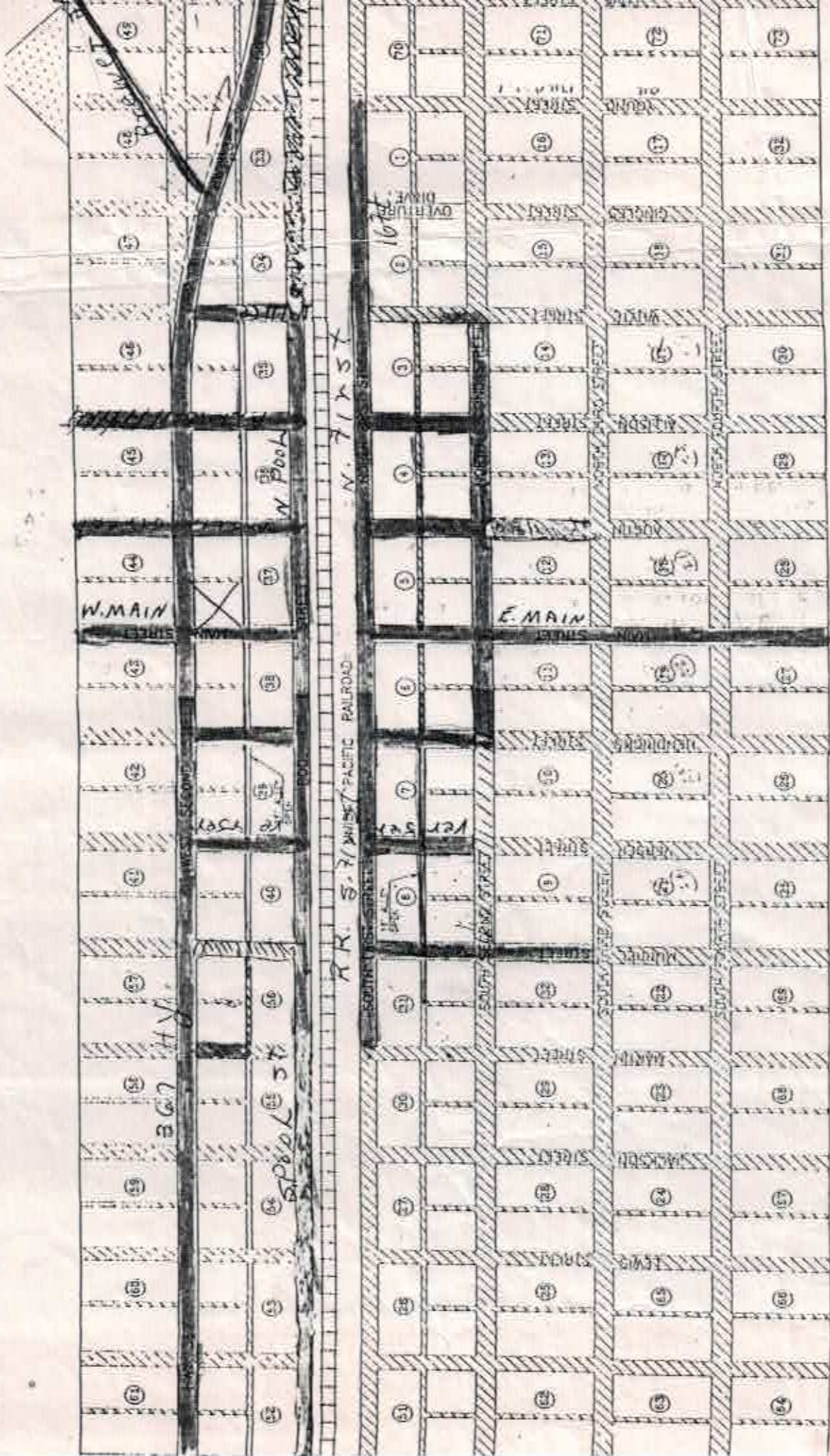
