

ORDINANCE NO. 03-96

AN ORDINANCE ADOPTING A MASTER STREET PLAN FOR THE CITY OF Austin, ARKANSAS; ESTABLISHING STREET CLASSIFICATIONS, RECOMMENDED PAVEMENT WIDTHS, AND RIGHTS-OF-WAY REQUIREMENTS FOR SPECIFIC STREETS AND HIGHWAYS; RESERVING RIGHTS-OF-WAY.

WHEREAS, cities of the first and second class are empowered by Ark. Stat. SS 19-2825 et seq. to adopt and enforce a plan or plans for the coordinated, adjusted, and harmonious development of themselves and their environs, and

WHEREAS, the Austin Planning Commission, following a public hearing on Sept 19-96, 1996 adopted a resolution recommending a revised Master Street Plan for the City and its planning area to the City Council for adoption,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF Austin, ARKANSAS:

THAT, the Master Street Plan document and map as prepared and recommended by the Austin Planning Commission be hereby adopted by this ordinance.
